### Information regarding payment of fees

1. Payment of fees is according to our rules on our school's homepage.
2. With admission to the boarding school, an administration fee of DKK 1,500 will be charged. A student cannot be admitted to the boarding school until the amount has been paid. The administration fee is non-refundable.
3. In connection with the application, financial information of parents should be given for students under 18 years. Financial information is needed so the school can calculate the boarding fees. The government order about admission of boarding school students and payment for boarding at institutions of upper secondary, education of 11 December 2006 section 4, 2, gives the school permission to obtain information about income of parents, and if relevant, a new partner/spouse and the boarding school student.

Tax payers in Greenland, the Faroe Islands and abroad must attach documentation from tax authorities.

4. If well-documented income information is not given, the school is entitled to charge the maximum boarding fee.
5. It is the student's parents who are obliged to pay the full boarding school fees. This applies even if the student is over 18 years.
6. Payment for boarding occurs monthly, in advance, on the first of each month. Payment can be made by bank transfer. Payment is made for the months August to June. If payment is late, there will be a reminder fee of DKK 100 and max DKK 250.
7. When vacating the boarding school, there is a period of notice of 2 months from the first of the month. Therefore, payment must be made for the month when notice is received and the following two months.
8. If payment for the boarding school is not made, the boarding school has the right to expel a student.
9. If a student is expelled from the boarding school, rule number 7. will take effect. With expulsion from the boarding school, the student and/or parents are in breach of the agreement and must follow the same rules as others who vacate before time.

**If you have questions regarding admission or rules regarding the State Education grant and loan scheme, then do not hesitate in contacting the school.**

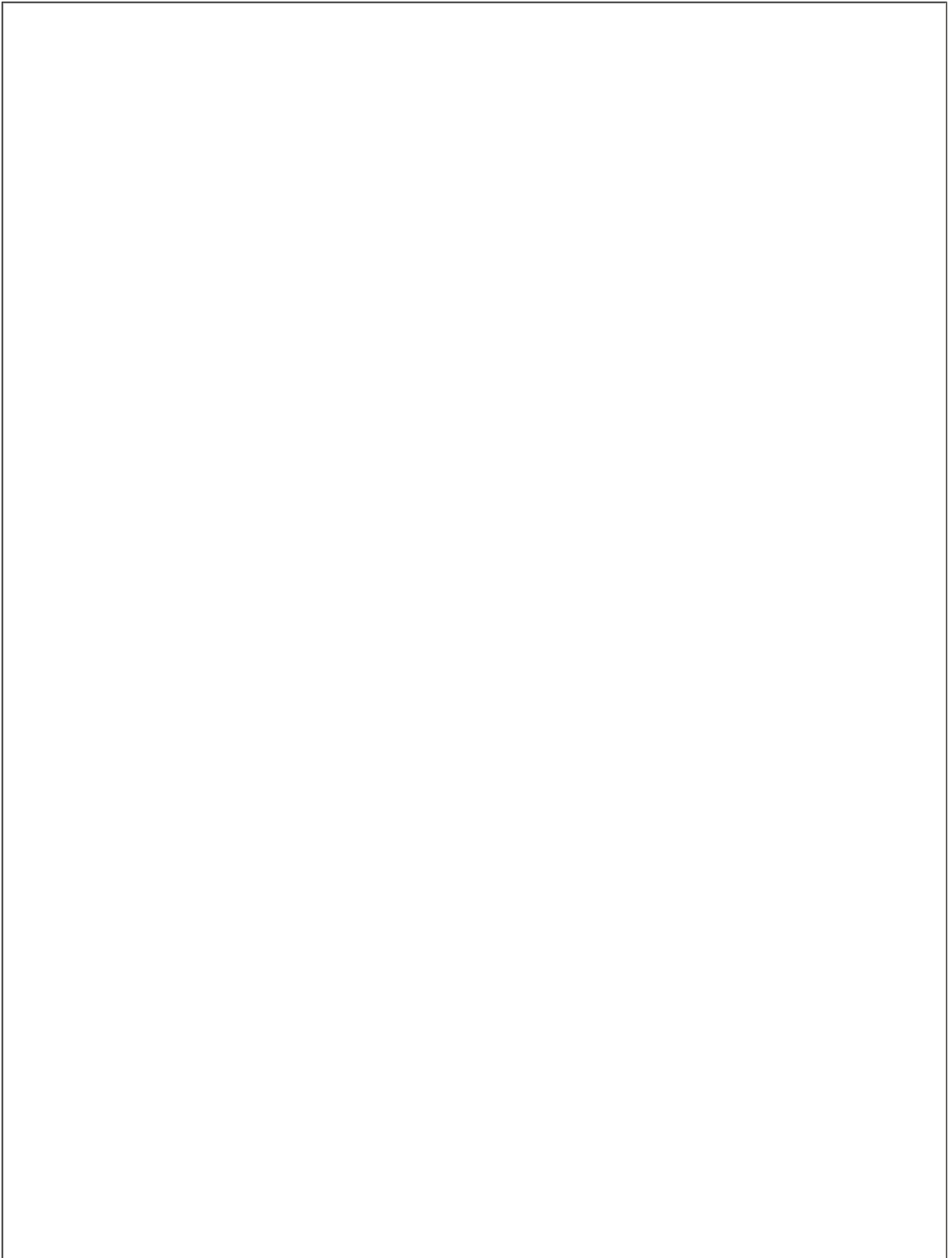
